MEAL PROGRAM FOR WOMEN AND CHILDREN LIVING IN POVERTY. OASIS SERVES THOSE FIGHTING POVERTY BY OFFERING DAILY BREAKFAST AND LUNCH IN OUR SOUP KITCHEN. ANNUALLY, OASIS SERVES 65,000 MEALS, BOTH TO CLIENTS RECEIVING OTHER SERVICES AS WELL AS MEMBERS OF THE GREATER PATERSON COMMUNITY. IN RESPONSE TO THE PANDEMIC, FROM MID-MARCH THROUGH JUNE, OASIS SHIFTED FROM THEIR NORMAL OPERATION TO A "GRAB AND GO" THAT RESULTED IN SERVING FROM 150 MEALS PER DAY TO A PEAK OF 1,900 MEALS PER DAY.
